First Habib Income Fund has been established in Pakistan by a Trust Deed dated 6th September, 2006, registered under the Trusts Act 1882 between Habib Asset Management Limited as the Management Company and Central Depository Company of Pakistan Limited as the Trustee and authorized under the Non-Banking Finance Companies (Establishment & Regulation) Rules, 2003.

Effective October __, 2016 the Offering Document of First Habib Income Fund has been amended as under:

1) The Annexure-B will be changed and read as follows:

Current Level of Front-End (Sales) Load : 1%

(Management has the discretion to reduce or waive SL on any transaction)

Further, AMC shall ensure that no sales load is charged if the investor approaches directly for investment or where transactions are done online through a website
