

## AND

Central Depository Company of Pakistan Limited (CDC), a company incorporated under the Companies Ordinance, 1984 and registered with the Securities and Exchange Commission of Pakistan (SECP) as a central depository company, with its registered office at CDC House, 99-B, Block-"B", SMCHS, Main Shahrah-e-Faisal, Karachi, (hereinafter called "Trustee"), which expression, where the context so permits, shall include its successors-in-interest and assigns of the other part.

## WHEREAS:

- The Management Company and the Trustee executed a Trust Deed dated 6<sup>th</sup> September 2006, constitute First Habib Income Fund (referred to in the said Trust Deed as "Scheme", "the Trust" or "the "Unit Trust"), an open ended scheme under Non-Banking Finance Companies (Establishment and Regulation) Rules 2003 ("the Rule"), which Trust Deed has been registered with Sub-Registrar II, Saddar Town, Karachi, under Registered No. 503 of Book No. IV dated 06-09-2006 and M.F Roll No. U 74113/3712 of the Photo Registrar, Karachi dated 16-09-2006 (hereinafter called "the Trust Deed").
- (2) The Management Company and the Trustees have mutually agreed to amend Trust Deed by virtue of the powers contained in sub-clause 13 thereof, without altering the fundamental objects of the Trust or releasing Trustee or the Management Company from any responsibility to the Unit Holders.

(3) The Securities & Exchange Commission of Pakistan (the Commission) has approved the amendment to the Trust Deed, vide its letter No. SCD/AMCW/FHIF/916/2014 dated March 14, 2014, which amendment is being hereby effectuated by this Third Deed of amendment of Trust deed.

## THIRD SUPPLEMENTAL TRUST DEED WITNESSETH AS FOLLOWS:

Effective May 15, 2014 the Trust Deed of First Habib Income Fund has been amended as under:

1) The clause 16.8 will be inserted and read as follows:

The Benchmark for "First Habib Income Fund" shall be 50% average of 6 months KIBOR and 50% 6 month bank deposit rate of (3) A minus and above rated banks.
