1. NAME AND CATEGORY OF THE SCHEME:

"First Habib Cash Fund" (FHCF) an open-end Money Market Scheme.

### 2. PARTICIPATING PARTIES:

- (1) HABIB ASSET MANAGEMENT LIMITED, a Non-banking Finance company, reproposated under the Companies Ordinance, 1984 with its registered office at 1st Floor Imperial Collin Dr. Ziauddin Ahmed Road, Karachi (hereinafter called the "Management Company" which expression where the context so permits shall include its successors in interest and assigns) of the one part; and
- (2) CENTRAL DEPOSITORY COMPANY OF PAKISTAN LIMITED ("CDC"), a company incorporated under the Companies Ordinance, 1984 and registered with the Securities and Exchange Commission of Pakistan (SECP) as a central depository company, with its Registered Office at CDC House 99-B, Block B, S.M.C.H.S, Main Shahra-e-Faisal, Karachi (hereinafter called the "Trustee", which expression, where the context so permits, shall include its successors in interest and assigns) of the Other Part.

### WHEREAS:

- A. The Management Company is engaged in the business of providing asset management services and has been licensed by the Securities and Exchange Commission of Pakistan (SECP) under the Non Banking Finance Companies (Establishment and Regulations) Rules, 2003 vide license No. NBFC-II/14/HAML/AMS/08/2010 dated April 06, 2010 (appended hereto as Annexure A) to suggest asset management services;
- B. The Management Company has been allowed by SECP vide its letter No. NBFC/MF-RSIPNCF/2010/555 dated July 13, 2010 appended hereto as Annexure "B" to constitute the Tripst duper the name and title of First Hotal Cash Fund (thereinafter referred to as the "Unit Trips" br "Trust" or "Scheme" or the "Fund") and to register this Trust Deed (Deed), pending registration of the Scheme under the Non-Banking Finance Companies and Notified Entities Registration, 2008 (hereinafter referred to as the Regulations) and this Deed.
- C. The Mariagement Company has nominated and appointed CDC as trustee of the Trust and Strustee has accepted such appointment upon the terms and conditions and tariff structure for trusteeship contained in Annexure C.
- D. SECP has approved the appointment of Trustee, vide letter No. NBFC/MF-RS/FHCF/2010/556 dated July 13, 2010 appended hereto as Annexure "D".

### NOW, THEREFORE, THIS DEED WITNESSETH AS FOLLOWS:

### 3. DEFINITIONS

- 3.1 Unless the context requires otherwise the following words or expressions shall have the meaning respectively assigned to them viz.
- 3.1.1 "Accounting Date" means the thirtieth day of June in each year and any interim date(s) at which the financial statements of the Trust are drawn up. However, the Management Company may, with the consent of the Trustee and after obtaining prior approval of the Commission and any other relevant authority change such date to any other taste.

Their Kit

- 3.1.2 "Accounting Period" means a period ending on and incitation on a commencing (in case of the first such period) on the date on which the Trust praperty is first paid or transferred to the Trustee and (in any other case) from the next first of the accounting Period.
- 3.1.3 "Annual Fee" means any fee payable to SECP under the Regulations.
- 3.1.4 "Account Statement" means statement of transactions in Units in the account of the Holder.
- 3.1.5 "Annexure" means the annexure to this Deed.
- 3.1.6 "Auditor" means a firm of Chartered Accountants appointed by the Management Company with the consent of the Trustee, as per the Regulations.
- 3.1.7 "Authorized Branch" means those branches of the Distributor(s)/Distribution Company (ies) that have been authorized by the Management Company. It also includes the distribution centers established by the Management Company to perform the Distribution Function.
- 3.1.8 "Authorized Investments" means Government securities, cash and near cash instruments which include cash in bank accounts (excluding TDRs), treasury bills, money market placements, deposits, certificate of deposits (COD), certificate of musharakas (COM), TDRs, commercial papers, reverse repo;
- 3.1.9 "Back-end Load" means the charge (excluding Duties and Charge) not exceeding 5% of the Net Asset Value, deducted from the Net Asset Value in determining the Redemption Price and it shall become part of the Fund Property;
- 3.1.10 Bank" means a banking company licensed under the Banking Companies Ordinance, 1982 garry other regulation for the time being in force or if operating outside Pakistan, under the spikking taws of the jurisdiction of its operation outside Pakistan.
- 3.1.11 Sank Accounts" means those accounts opened and maintained for the Trust by the Trustee at Banks, the beneficial ownership of which rests with the Unit Holders.
- 3.7.12 "Bonus Units" means the Units issued instead of cash dividend, on distribution of the distributable income.
- 3.1.13 "Broker" means any person licensed by the Commission and engaged in the business of effecting transactions in securities for the account of others.
- 3.1.14 "Business Day" means a day, Monday to Friday, on which Scheduled Banks, are open for business in Pakistan.
- 3.1.15 "Certificate" means the definitive certificate acknowledging the number of Units registered in the name of the Holder issued at the request of the Holder pursuant to the provisions of this Deed.
- 3.1.16 "Companies Ordinance" means the Companies Ordinance, 1964, as amended or substituted from time to time.

3.1.17 "Commission" or "SECP" means the Securities and Exchange Commission.rglgHatstath (SECP), established under the Securities and Exchange Commission of Pakistan Agi, 1997 achi

- 3.1.18 "Connected Person" shall have the same meaning as in the Regulations.
- 3.1.19 "Constitutive Documents" means this Trust Deed which is the principal document governing the formation, management or operation of the Trust and the Offering Document and all other related material agreements.
- 3.1.20 "Core Investor(s)" means the investor(s) who shall be 'required to subscribe to and to hold number of Units of an amount to be in compliance with Sub-Clause (ii) of Cause (e) of Sub-Regulation (3) of Regulation 44 of the Regulations for such period from the date of close of Initial Offer Period as specified in the Regulations. Particulars of the Core Investors shall be included in the Offering Document that shall be issued for this Trust.
- 3.1.21 "Core Units" means such Units of the Trust that are issued to Core Investors with the condition that these Units are not redeemable for a period of two years from the date of close of initial Offer Period, Such Units are transferable with this condition and shall rank pari passu with all other Units save for this restriction. Any transfer of the Core Units, during the first two years of the date of close of Initial Offer Period, shall be affected only on the receipt by the Transfer Agent of a written acceptance of this condition by the transfere.
- 3.1.22 "Custodian" means a banking company within the meaning of the Banking Companies Ordinance, 1962 (LVIII of 1962), or a depository company approved by the Commission for the time being, appointed by the Trustee with the approval of the Management Company to Look and protect the Fund Property or any part thereof as Custodian on behalf of the Fuddee. The Trustee may also listell provide custodial services for the Trust at competitive limits, as part of the normal line of its business.
- 3.1.23 "Cits'Off Time" Cut-off timing for receiving applications of issuance, redemption, conversion, transfer, pledge etc shall be mentioned in the Offering Document
- 3.1.24 "Bigribution Account" means the Bank Account which may be a current, saving or upost account maintained by the Trustee with a scheduled commercial Bank having a minimum AA rating as per the criteria laid down by the credit rating agency approved by the SECP, approved by the Management Company in which the amount required for the distribution of income to the Holders shall be transferred, interest, income or profit, if any, including those accruing on unclaimed dividends, in this account shall be transferred to the main account of the Fund from time to time, as part of the Trust Property for the benefit of the Unit Holder(s).
- 3.1.25 "Distributor / Distribution Company" means a company, firm or a Bank appointed by the Management Company in consultation with the Trustee for performing the Distribution Function and shall also include the Management Company, if it performs the Distribution Function.
- 3.1.26 "Distribution Date" means the date on which the Management Company decides to distribute the profits (if any).
- 3.1.27 "Distribution Function" means with regard to:
  - (a) Receiving applications for issue of Units together with the aggregate Offer Price for





Units applied for by the applicants;

(b) Issuing of receipts in respect of (a) above;

- (c) Interfacing with and providing services to the Holders-Tooledings/Receiving redemption applications, transfer applications, conversion notices and applications for change of address or issue of duplicate Certificates for Immediate transmission, in accordance with the instructions given by the Management Company or the Trustee, to the Management Company or the Transfer Agent as appropriate; and
- (d) Accounting to the Management Company for all (i) Moneys received from the applicants for issuance of Units; (ii) payments made to the Holder(s) on redemption of Units; and (iii) all expenses incurred in relation to the Distribution function.

The Distribution Function is the sole responsibility of the Management Company and any of its expenses shall not be charged to the Fund Property as mentioned in Clause 25'2 below.

- 3.1.28 "Duties and Charges" means in relation to any particular transaction or dealing all stamp and other duties, taxes, Government charges, bank charges, transfer fees, registration fees and other duties and whether in connection with the constitution of the Fund Property or the increase or decrease of the Fund Property on the creation, issue, sale, transfer, redemption or purchase of Units or on the sale or purchase of Investments or in respect of the issue, transfer, cancellation or replacement of a Certificate or otherwise which may have become or may be payable in respect of or prior to or upon the occasion of the transaction or dealing in respect of which such Duties and Charges are payable but do not include the remuneration payable to the Distribution Company or any commission, charges osts which may have been taken into account in ascertaining the Net Asset Value.
- 3.1.29 Expesure" shall have the same meaning as in the Regulations.
- 3.1.30 "Financial Institutions" includes:-

A company or an institution whether established under any special enactment and operating within or outside Pakistan which transacts the business of banking or any associated or ancillary business through its branches;

- A moderaba, leasing company, investment bank, financing company, housing finance company, a non-banking finance company; and
- (c) Such other institution or companies authorized by law to undertake any similar business as the Federal Government may, by notification in the official Gazette, specify for the purpose.
- 3.2.31 "Force Majeure" means any occurrence or circumstance or element which delays or prevents performance of any of the terms and conditions of this Dead or any obligations of the Management Company or the Trustee and shall include but be no limited to any circumstance or element that cannot be reasonably controlled, predicted, evoided or overcome by any Party and which occurs after the execution of this Agreement and makes the performance of the Agreement in whole or in part impossible or impracticable or delays the performance, including but not limited to any situation where performance is impossible without unreasonable expenditure. Such circumstances include but are not limited to floods, fires, droughts, typhocors, earthquakes and other acts of God and other unavoidable or





unpredictable elements beyond reasonable control, such as war (dectable or undocurred), insurrection, civil war, acts of terrorism, accidents, strikes, riots, turmol, other elements act or omission of a governmental authority, failure of communication system-elements or computer system and transmissions by unscrupulous persons, closure of stock exchanges, banks or financial institutions, freezing of economic activities and other macro-economic factors, etc.

- 3.1.32 "Formation Cost" means all preliminary and floatation expenses of the Trust including expenses in connection with registration of the Scheme, execution and registration of the Constitutive Document, issue, circulation and publication of the Offering Document, legal costs and all other expenses incurred during and up to the Initial Period. Provided, however that the formation cost will not exceed the first specified in the NEET G. NE Regulations
- 3.1.33 "Front-end Load" means the sales and processing charge not exceeding five percent of NAV applicable to certain classes of units that is included in the Offer Price of the Units as per details in the Trust Deed and Offering Document.
- 3.1.34 "Fund Property" means the aggregate proceeds of the sale of all Units at Offer Price after deducing there from or providing there out any applicable Front-end Load and Duties and Charges and Transaction costs and any other expenses chargeable to the Fund (as specified in Clause 36.4) and after adding thereto any charges for redemption of Units in the form of Back- end Load (if any) as specified in the Offering Document, and includes the investment and all income, profit and other benefits arising there from and all cash, bank balances and other assets and property of every description for the time being held or a degree of the benefit of the Holders pursuant to this "Desk but does not include any amount standing to the credit of the Distribution Account."
- 3.1.35 "Holder" or "Unit Holder" means the investor for the time being entered in the Register %) as dwish of a Unit, including investors jointly so registered pursuant to the provisions of this
- 3.1.26 "Initial Period" or "Initial Offering Period" means a period determined by the dangagement Company not exceeding thirty (30) days during which Units shall be offered at A CVD Par Value in terms of the Offering Document, inclusive of the offering to the Core measures.
- 3.1.37 "Investment" means any Authorized Investment forming part of the Fund Property.
- 3.1.38 "Management Company" or "Asset Management Company" means Habib Asset Management Limited.
- 3.1.39 "Minimum Investment Amount" shall initially be Rupees One Thousand (Rs 1,000/-) or as may be determined by the Management Company from time to time and mentioned in the Offering Document.
- 3.1.40 "Net Assets", means the excess of assets over liabilities of the Trust, such excess being computed in the manner specified under the Regulations.
- 3.1.41 "Net Asset Value" or "NAV" means per Unit value of the Trust arrived at by dividing the Net Assets by the number of Units outstanding.
- 3.1.42 "Offer Price" means the sum to be paid to the Trustee for issuance of one Unit, such price





to be determined pursuant to Clause 24 of this Deed.

- 3.1.43 "Offering Document" means the document (approved by SECP), which contains the investment and distribution policy and all other information in respect of the Unit Trust, as required by the Regulation and is circulated to invite offers by the public to invest in the Unit Trust and includes any other Supplementary Offering Document.
- 3.1.44 "Par Value" means the face value of a Unit that shall be One Hundred (Rs. 100/40).
- 3.1.45 "Pre IPO" means the period preceding the Initial Period during which investments and initials in 11.11 the Scheme by the Pre-IPO Investors.
- 3.1.46 "Pre IPO Investor(s)" mean(s) the investors who make investments in the Scheme before the Initial Period.
- 3.1.47 "Redemption Price" means the amount to be paid to the relevant Holder of a Unitupon redemption of that Unit, such amount to be determined pursuant to Clause 27 of this Deed.
- 3.1.48 "Register" means the Register of the Holders kept pursuant to the Regulations and this Deed.
- 3.1.49 "Registrar/Transfer Agent means a company including a Bank that the Management Company shall appoint for performing the Registrar Functions. The Management Company may isself perform the Registrar Function.
- 3.1.50 Registrar Function" means the function with regard to:

Maintaining the Register;

Processing requests for issue, redemption, transfer and transmission of Units and requests for recording of pledge or for recording of changes in information / particulars / data with regard to the Holders;

Issuing Account Statements to Holders:

- (d) Issuing Certificates including Certificates in lieu of undistributed income to Holders;
- (e) Dispatching income distribution warrants and allocating Units to Holders on reinvestment of dividends as per Clause 39 of this Deed:
- (f) Cancelling old Certificates on redemption or replacement;
- Maintaining records of lien / Piedge / charge on units, transfer / switching of units, Zakat; and
- (h) Keeping record of change of addresses / other particulars of the Holders.

The Registrar Function is the sole responsibility of the Management Company.

3.1.51 "Regulations" means the Non-Banking Finance Companies and Notified Entities Régulations, 2008 as amended or substituted from time to time.







- 3.1.52 "Reporting Currency / Base Currency" means the currency used in pricing of units and presenting the financial statements of the Fund which shall be the Pakistani Rupee.
- 3.1.53 "Rules" means the Non-Banking Finance Companies (Establishment and Regulation) Rules, 2003, as amended or substituted from time to time.
- 3.1.54 "SBP" means State Bank of Pakistan.

- 3.1.55 "Stock Exchange" means any stock exchange registered under the Sections & Exchange Ordinance, 1999 and shall include stock exchanges registered and operating outside Pakistan.
- 3.1.56 "Subscription Day" means every Business Day on which Units are available for subscription provided that the Management Company may with the prior written consent of the Trustee and upon giving not less than seven (7) days prior notice in at least two newspaper, English and Urdu circulating in Pakistan, declare any particular Business Day not to be a Subscription Day. Such notice shall be deemed to be duly served on the Holder.
- 3.1.57 "Supplementary Trust: Deed" means a supplemental deed executed between the Management Company, and the Trustee, with the approval of SECP describing any amendments made to the Deed, pursuant to Clause 42 of Deed.
- 3.1.58 "Transaction Costs" means the costs incurred or estimated by the Management Company to cover the costs (such as, but not restricted to, brokerage, Trustee charges, taxes or levies or series or distinct of the series may be added to the NAV transactions, the series of the series of the NAV in determining the Offer Piffee of Units or to be deducted from the NAV in determining the Registration Price. The element of Transaction Costs taken into account in determining the pricessand collected so, shall form a part of the Trust Property.
- 3.1.59 "Trust", "Unit Trust", "Fund", "Collective Investment Scheme" or "Scheme" means

- 3.2 Words and, expressions used but not defined herein shall have the meanings assigned to them in the Ordinance, the Rules or the Regulations. Words importing person include corporations, words-importing the masculine gender include the feminine gender, wordsimporting singular include plural words, "writen" or "in writing" include printing, engraving, lithography, or other means of visible reproduction.

#### 4. GOVERNING LAW

4.1 This Deed shall be subject to and be governed by the Laws of Pakistan, including the Rules and the Regulations and all other applicable taws, rules and regulations, as amended or replaced from time to time, and it shall be deemed for all purposes whatsoever that all the provisions required to be contained in a trust deed by the Regulations are incorporated in this Deed as a part and parcel hereof and in the event of any conflict between the provisions contained in this Deed and the provision of the Regulations, the latter shall prevail over the provisions contained in this Deed, unless a waiver has been obtained from the SECP. The Fund

shall also be subject to the rules and regulations framed by the State Both.c.f. Pakisten-with regard to the foreign investments made by the Fund and investments made Setale Fund from outside Pakistan.

- 4.2 The Investments in offshore Countries and Bank Accounts and custodial services accounts that may be opened by the Trustee for the Scheme in offshore countries on the instructions of the Management Company may become subject to the laws of such Countries and shall always be subject to State Bank of Pakistan and SECP prior written approval.
- 4.3 Subject to the Arbitration Clause 45 hereafter, applicable between the Management Company and the Trustee Inter se, each party, including the Unit Holders irrevocably submit to the exclusive jurisdiction of the Courts at Karachi.

### DECLARATION OF TRUST

- 5.1 It is hereby declared unequivocally, that a Trust in the name and title of First Habib Cash Fund is hereby created and the Trustee is hereby nominated, constituted and appointed as the Trustee of the Trust. The Management Company and the Trustee hereby agree to such appointment and further declare that:
  - (a) The terms and conditions of this Deed and any deed supplemental hereto, made after getting prior approval of SECP, shall be binding on the Trustee, the Management Company and each Holder as if any of them has been a party to it and so to be bound by its provisions and each Holder authorizes and requires the Trustee and the Management Company to do as required of them by the terms of this Deed;
  - (b) Trie Management Company shall establish, manage, operate and administer the Trust;
  - (c) The Trustee shall hold and stand possessed of the Fund Property that may from time to time bereafter be vested in the Trustee upon trust as a single common fund for the benefit of the Holders ranking pari-passu inter se according to the number of Units held by each Holder;
  - The Fund Property shall be invested / disinvested from time to time by the Trustee at the direction of the Management Company strictly in terms of the provisions contained and the conditions stipulated in this Deed, the Offering Document, the Rules, the Regulations and the conditions, if any, that the Commission may impose from time to time;
  - (e) A Unit Holder shall not be liable to make any payment after he has paid the purchase price of his Units and that no further liability can be imposed on him in respect of Units that he holds except in the case of a Back-end Load which shall be applicable on redemption on certain class of Units, as scheduled in the Offering Document(s).
  - (f) The Trustee shall report to the Unit Holders in accordance with the Regulations, including a report to be included in the annual and second quarter report or at any frequency prescribed by the Commission whether in its opinion, the Management Company has in all material respect managed the Scheme in accordance with the provisions of the Rules, the Regulations and this Deed and if the Management Company has not done so, the respect in which it has not done so and the steps the Trustee has taken in respect thereof.
  - (g) The Trustee and Management Company may retire in the manner stated in Clauses 10 and 12





of this Deed:

(h) The Trust shall be managed and operated strictly in terms of the provisions contained and stipulated in this Deed, the Offering Document, the Rules (as amended or replaced from time to time), the Regulations (as amended or replaced from time to time) and the conditions, if any that may be imposed by SECP from time to time.

# STATEMENT OF THE INVESTMENT OBJECTIVE & INVESTMENT POLICY OF THE OPEN END SCHEME

6.1 Investment Objective:

Sub-Registrar-II The investment objective of First Habib Cash Fund, an open-end Money Market/Schlome, if the acini. provide its unit-holders optimum return from a portfolio of low risk and short duration assets while being highly liquid.

Investment Policy:

- The Fund shall invest in Government securities, cash and near cash instruments which include cash in bank accounts (excluding TDRs), treasury bills, money market placements, deposits, certificate of deposits (COD), certificate of musharakas (COM), TDRs, commercial papers, reverse repo; with a weighted average time to maturity of net assets of not more than 90 days and, in case of a single asset, maximum time to maturity of six months.
- Fund shall not take any direct or indirect exposure to equities i.e. no exposure in equities, CFS, spread transactions etc.

Fund shall not place funds with any NBFC or Modaraba with a rating lower than AAA (Triple A)

Fund shall not place deposit with any Bank or DFI with rating less than AA (double A)

Rating of any security in the portfolio shall not be lower than AA (double A).

The Fund will intend to reduce risk while maintaining liquidity. Liquidity will also be managed by opportunistically investing in the call money market when call money yields are attractive relative to other money market yields.

- The investment strategy of the Fund will be based on fundamental credit analysis (vii) and credit rating of counter parties.
- Specifically, the Investment strategy will focus on the following broad parameters:
  - a) Sponsor of the counterparty: Investments will be made keeping in mind the market reputation and past track record of the counterparty and its main sponsors.
  - b) Strength of financials and ability to repay: The strength and stability of counterparty earnings will be taken into consideration and special focus will be made on its cash flows and the resultant ability to repay the amount.
  - c) Rate of return offered; Attempt will be made to invest in those instruments that offer competitive returns vis-a-vis other similar investments in the market.

d) Industry fundamentals and future outlook: Industry outlook and its future potential will also be looked into at the time of investing. The Fund will seek to invest in those money market instruments that offer attractive market returns and are issued by sponsors with good credit rating, strong financials and ability to repay.

### 6.3 Benchmark

- 6.3.1 The Benchmark for "First Habib Cash Fund" shall be an average of "3 Month PKRV rate" for the period of return as available through Reuters and Financial Markets Association of Pakistan (FMA).
- 6.3.2 The performance of the Scheme shall be compared to its benchmark after deducting from the return all the expenses which are charged to the Scheme as per the Regulations;

# Investment / Exposure Restrictions

Such Investments may be made up to 30% of net assets of the Fund and are subject to a cap of US\$ 15 million unless some other ceiling is imposed by the SBP and/or SECP.
- 8.2 access the limit to international investment is exceeded, the Management Company and regularize the excess within three months of breach of the limit.
- 8.3 The Fund Property can be invested in international investments including the following:

- 8.4. While investing internationally, Fund Property will not be placed in any investment that has CH) the effect of unlimited liability to the Fund.
- 8.5 In making investments outside Pakistan, the currency of the investment shall be convertible currencies like the US Dollar, Pound Sterling, Euro and Japanese Yen or any other currency. This condition however will be relaxed in those cases where the Fund Manager figels that there exists cost effective conversion mechanism to convert foreign currency in Pakistani currency or any other convertible currency. Provided however the Base currency of the Fund shall always be considered as Pak Rupee.
- 8.6 Arrangements for international custody of securities where required will be made with reputable institutions and procedures will be agreed upon by the Trustee. The Management Company will make best efforts to minimize costs affiliated with international transactions so that the savings can be passed on to the unit holders.

### 9. DUTIES AND POWERS OF MANAGEMENT COMPANY





### 10. CHANGE OF MANAGEMENT COMPANY

The removal of the Management Company and appointment of a new management company shall always require the prior approval of the Commission and intimation of the same to the Trustee.

- 10.1 The Commission may either on its own or on the recommendation of the Trustee remove the Management Company by giving at least ninety days notice in writing for subclause (a) hereunder and immediate notice for sub-clause (b), (c) and (d) to the Management Company if any of the following events has occurred::
  - (a) The Management Company has wilfully contravened the provisions of this Deed in any material respect and has failed to rectify the contravention within a reasonable period after the contravention has been brought to its notice by the Trustee and/or by the Commission.
  - (b) The Management Company goes into liquidation;
  - (c) A receiver has been appointed over any of the assets of the Management Company.

- (d) If Management Company becomes ineligible to act as a Management Company of the Trust under the provisions of the Rules and/or Regulations, or any other law for the time being in force.
- 10.2 The Management Company may voluntarily retire at any time with the prior written consent of SECP and Trustee after giving three months prior notice to the Trustee and the Commission. Provided that until the new management company is appointed, the Management Company shall continue to perform its function as the management company.
- 10.3 If SECP has cancelled the licence of the Management Company under the provisions of the Ordinance and/or the Rules and/or Regulations, the SECP or the Trustee (if authorized by the SECP) shall appoint another asset management company so the Scheme according to the provisions of this Deed and the Regulations.
- 10.4 Upon a new management company being appointed, the Management Company shall take immediate steps to hand over all the documents and records pertaining to the Trust to the new management company and shall pay all sums due to the Trustee.
- 10.5 Upon its appointment the new management company shall exercise all the powers and enjoy all rights and shall be subject to all duties and obligations of the management company hereunder as fully as though such new management company had originally been a party hereto.
- 10.6 Fürthermore, the Trustee-may immediately upon the issuance of notice of removal of Management Company appoint Auditors with the consent of SECP from amongst the panel of Auditors designated as "A" category by the State Bank of Pukistan for the audit of Firagibial Institutions.
- 10.7 The Auditors so appointed shall be other than the existing Auditors of the Fund, the Marylgement Company and the Trustee.
- 10.8 The Auditors shall have the same scope as that for the annual audit, or such other enhanced scope as may be specified by the Trustee or SECP.
- 10.9 The Auditors shall submit the report for the audit to the Trustee not later than 30 Business Days from their appointment. A copy of the report shall also be provided to SECP, outgoing Management Company and the new Management Company
- 10.10 The cost of audit shall be shared equally by outgoing Management Company, the new Management Company, and the Fund.
- 10.11 In case of change, the old Management Company shall continue be liable for any default in or non-performance of its duties as the Management Company or for any negligence on its part or or part of its officer or officials, nominees or agents and for any acts or omissions effectuated prior to and upto the effective date in accordance with the provision of the Trust Deed and Offering Document, the Rules and the Regulations, where after the new Management Company shall be responsible for the same. Further the Old Management Company shall indemnify the new Management Company in respect of any default, non performance or violations of the terms and conditions of the trust deed, offering document, the Rules and / or Regulations that may have taken place, advertently or inadvertently prior to and

- 11.2 The Trustee shall take under its control all the property of the scheme and hold it in trust for the Unit Holders in accordance with the Regulations, the Deed and all applicable laws and all cash and registerable assets shall be registered in the name of or to the order of the Trustee.
- 11.3 The Trustee shall exercise all due difigence and vigilance in carrying out its duties and in protecting the interests of the Unit Holders. The Trustee shall not be under any liability on accipant of anything done or suffered by the Scheme, if the Trustee had acted in good faith in perfolmance of its duties under this Trust Deed in accordance with or in pursuance of any request of the Management Company, provided these were not in conflict with the provisions of this Deed or the Rules or the Regulations. Whenever pursuant to any provisions of this Dejectualry certificate, notice, direction, instruction or other communication is to be given by the Management Company to the Trustee, the Trustee may accept as sufficient evidence thereof:

A document signed or purporting to be signed on behalf of the Management Company by any person(s), whose signature the Trustee is for the time being authorized in writing by the Management Company to accept.



- 11.5 The Trustee shall carry out the settlements in accordance with the dictates of the specific transactions as instructed by the Management Company unless such instructions are in conflict with the provisions of this Deed and/or the Offering Document(s) and/or the Regulations.
- 11.6 The Trustee shall, in consultation with the Management Company, from time to time appoint, remove or replace one or more Custodian for performing the Custodian Function as one or more locations, on terms and conditions to be agreed between the Custodian and the Trustee and approved by the Management Company. Provided however, the Trustee may also itself perform Custodian Function for the Trust with the approval of the Management Company at competitive terms, as part of its normal line of business.
- 11.7 The Trustee shall make available or ensure that there is made available to the Management Company such information and/or reports as the Management Company may reasonably require from time to time in respect of the Fund Property and all other matters relating to the Scheme.
- 11.8 The Trustee shall issue a report to the Unit Holders included in the annual and second quarter report of the Fund and therein state whether in its opinion, the Management Company has in all material respects managed the Fund in accordance with the provisions of the Rules and Regulations and this Deed and if the Management Company has not done so, the respect in which it has not done so and the steps the Trustee has taken in respect thereof.
- 11. 9 The Trustee may require the Auditors to provide such reports as may be considered nicespary to facilitate the Trustee in issuing the certification required under the Regulations. The Trustee shall endeavor to provide the certification at the earliest date reasonably possible.
- 11.10 The Thistee shall authorize and facilitate the Management Company to receive the copies of y statements of account for all the scheduled commercial Bank Accounts being operated by the Trustees a nominee of the Trust.
- 11.11 Trustee shall ensure that the methods and procedure adopted by the Management company in calculating the value of Units are adequate to ensure that the sale, issue, repurchase, "and redemption prices are calculated in accordance with the provisions of the Regulations and this Deed.
- 11.12 The Trustee shall, if requested by Managemeint Company or if it considers necessary for the protection of Trust Property or safeguarding the interest of Unit Holder(s) institute or defend any suit, proceeding, arbitration or inquiry or any corporate for shareholders' action in respect of the Fund Property or any part thereof, with full powers to sign, swear, verify and submit pleadings and affidavits, to file documents, to give evidence, to appoint and remove coursel and to do all incidental acts, things and deeds. All reasonable costs, charges and expenses (including reasonable legal fees) incurred in instituting or defending any such action shall be borne by the Trust and the Trustee shall be indemnified against all such costs, charges and expenses: Provided that no such indemnity shall be available in respect of any action taken against the Trustee of gross negligence or breach of fiduciary duties in connection with its duties as the Trustee under this Deed or the Regulations. The Trustee and the Management Company shall not be liable in respect of any losses, claims,





damages or other liabilities whatsoever suffered or incurred by the Trust appears, from or consequent to any such suit, proceeding, arbitration or inquiry or corporate of shareholders action or otherwise howsoever and (save as herein otherwise provided), all such losses, claims, damages and other liabilities shall be borne by the Trust.

- 11.13 Neither the Trustee nor the Custodian (if Trustee has appointed another person as Custodian) or any of its connected persons shall sell or purchase or deal in the sale of any investment or enter into any other transaction with the Trust.
- 11.14 Trustee shall not invest in the units of Fund.
- 11.15 The Trustee shall not be under any liability except such liability as may be expressly assumed by it under the Regulations and this Deed nor shall the Trustee blable for any act or omission of the Management Company or for anything except its own negligence or willful breach of duty hereunder. The Trustee shall not be under any liability by reason of any error of law. Notwithstanding removal / resignation of Trustee, the Trustee shall remain emitted to the benefit of this Clause.
- 11.16 The Trustee shall not be liable for any loss caused to the scheme due to Force Majeure.
- 11.17 The Trustee shall provide the Management Company with regular reports or other documents issued by the issuers of securities, recipients of any of the Trust funds (as deposits, refunds, distribution of dividends, income, profits, repayment of capital or for any other reason) which are due to be received or , any depository, an intermediary or agent in any transaction or from any court, government, regulator, stock or other exchange or any other, party having any connection with the transaction. The Trustee shall promptly act on any instruction of the Management Company in all such matters relating to recovery of the Fund Property.
- 11.18 The Trustee shall promptly provide proxies if requested by the Management Company with regard to any voting rights attaching to any investment.
- 11.19 The Trustee shall be required to adhere to performance standards, as mutually agreed appropriate the Management Company and the Trustee, from time to time.
- 11-20 The Trustee shall ensure that the investment and borrowing limitations set out in the Regulations are compiled with.
- 11.21 The Trustee shall ensure that the sale, issue, re-purchase, redemption, transfer and cancellation of Units are carried out in accordance with the provisions of the Constitutive Document;
- 11.22 The Trustee shall arrange for its annual system audited by an Auditor and provide the report of such audit to the Commission and the Management Company, within four months of the close of the financial year of the Trustee.
- 11.23 The Trustee shall ensure that the Management Company has specified criteria in writing to provide for a diverse panel of brokers and shall also ensure that the Management Company has been diligent in appointing brokers to avoid undue concentration of business with any broker.
- 11.24 The Trustee shall ensure that Unit Certificates are not issued until subscription money has





been received in the Fund.

11.25 The Trustee shall ensure that the methodology and procedures adopted by the Management Company in calculating the value of Units are adequate and the pricing and valuation for sale, issue, repurchase and redemption are carried out in accordance with the provisions of this Trust Deed, the Offening Document and the Regulations and any other regulatory requirement.

- 11.26 The Trustee shall immediately inform the Commission if any action of the Management Company contravenes the Ordinance, the Rules, the Regulations, Constitutive Documents, guidelines, codes, circulars, directives or any other applicable laws.
- 11.27 The Trustee shall compty with the directions of the Commission given in the interest of the Unit Holders.
- 11.28 The Trustee shall ensure that the conditions under which the Scheme was registered are complied with.
- 11.29 The Trustee shall nominate one or more of its officers to act as attorney(s) for performing the Trustee's functions and for interacting with the Management Company.
- 11.30 In case of any modification or alteration in the Trust Deed or the Offering Document of the Fund, the Trustee shall ensure and verify that such amendments shall not prejudice the interest of the unit holders.
- 11.31 The Trustee shall ensure that where applicable, payments against investments are made against delivery and vice versa, unless specified otherwise.

# 12. CHANGE OF TRUSTEE

- 12.1 A Training may, subject to prior approval of the Commission and under intimation to the Management Company, retire from his office on appointment of a new trustee and the reference that take effect at the same time as the new trustee is appointed, with the approval of the Commission, or from the date of assumption of assets of the Fund by the new appointed trustee, whichever is later. In the event of the Trustee desiring to retire, the Management Company may, within a period of ninety (90) days, with the prior written approval of SECP and by a deed supplemental hereto under the seal of the Management Company and the trustees (both incoming and outgoing Trustee), appoint a new furstee in place of the retiring Trustee, under the provisions of the Rules and the Regulations, and also provide in such deed for automatic vesting of all the assets of the Trust in the name of the new trustee.
- 12.2 Where the Commission is of the opinion that Trustee has been in violation of the Regulations or the Deed or is found guilty of misconduct or failed to discharge its obligations under the Regulations, it may remove the Trustee after giving the Trustee an opportunity of being heard.
- 12.3 The Management Company may by giving reasons in writing apply to the Commission for change of the trustee and propose a new trustee.
- 12.4 The Commission, if satisfied by the reasons given by the Management Company and after providing an opportunity of hearing to the trustee, may approve the removal of the existing and





the appointment of a new trustee.

- 12.5 Upon the appointment of a new trustee, the trustee shall immediately deliver and hand over all the documents and records to the new trustee and shall transfer all the Fund Property including any amount held in any of the Bank Accounts of the Scheme to the new trustee and make payments to the new trustee of all sums due from the Trustee.
- 12.6 The new trustee shall exercise all the powers and enjoy all rights and shall be subject to all duties and obligations of the Trustee hereunder as fully as though such new trustee had originally been a party hereto.
- 12.7 Notwithstanding the removal/resignation of the Trustee and its subsequent discharge from its duties under this Deed and the Regulations, the Trustee shall remain responsible or obligated to liquidate any liability for which the Trustee may have become liable under this Deed and/or the Regulations and also remain entitled to the benefit under the terms of this Deed till the removal/ resignation of the trustee is effective.
- 12.8 Furthermore, the Management Company may immediately upon the issuance of notice of removal of Trustee appoint Auditors with the consent of SECP from amongst the panel of Auditors designated as "A" category by State Bank of Pakistan for the audit of Financial Institutions.
- 12.9 The Auditors so appointed shall be other than the existing Auditors of the Fund, the Management Company and the Trustee.
- 12.10 The Auditors shall have the same scope as that for the annual audit of the Scheme, or such other enhanced scope as may be specified by the Management Company or SECP.
- 12.11 The Auditor shall submit the report for such audit to the Management Company not later than +30 business Days from their appointment. A copy of the report shall also be provided to SECP, -304-50 bg Trustee and the new Trustee.
- 12.12 The cost of such audit shall be shared equally by the outgoing Trustee, the new Trustee
- 12.13 In case of change, the old trustee shall continue to be liable for any default in or nonperturnation of its duties as trustee or for any negligence on its part or on part of its officer or
  officials, normnees or agents and for any acts or omissions effectuated prior to and upto the
  Medictive time in accordance with the provision of trust deed and offering document, the Ruiesand the Regulations, whereafter the new trustee shall be responsible for the same. Further
  the old trustee shall indemnify the Management Company and the new trustee in respect of
  any default, non performance or violations of the terms and conditions of the trust deed,

### 13 BANK ACCOUNTS

- 13.3 The Management Company may also require the Trustee to open a separate Bank Account for dividend distribution out of the Scheme.
- All bank charges for opening and maintaining Bank Account(s) for the Scheme shall be charged to the Scheme.
- All interest, income, profit etc earned in the Distribution Account(s), including those accruing on unclaimed dividends, shall form part of the Trust Property for the benefit of the Unit Holder(s) and shall be transferred periodically from the Distribution Account(s) to the main Bank Account of the Scheme.
- The amounts received from the Core Investors (seed capital) and Pre-IPO investors shall be deposited in a separate Bank account titled CDC Trustee - First Habib Cash Fund and transferred to the main Bank Account of the Scheme upon the close of the Initial Period. The Management Company may issue additional Units to the Core Investors and Pre-IPO investors at the initial Price for an amount equivalent to the income etc earned on their investments up to the close of the Initial Period.
- 13.7 The Trustee shall, if requested by the Management Company open Bank Accounts titled "CDC - Trustee First Habib Cash Fund" in offshore countries where the Investments are made on account of the Fund, if such Investments necessitate opening and operation of Bank, Accounts by the Trustee. For this purpose, the Trustee shall be deemed to be authorized to wing and submit the prescribed account opening forms of such Banks, including dedial'sub-custodial services accounts and brokerage accounts with such Banks, Custodians, Sub-Custodians, and brokers, as may be required to be appointed for offshore finels/ments of the Fund. The opening, operation and maintenance of such Bank Accounts. custodial sub-custodial and brokerage services accounts in offshore countries shall always be subject to the approval of the SBP and the exchange control regulations, as well as any directives of the SBP and/or the Commission.



- 14.1 The aggregate proceeds of all Units issued from time to time after buties and Charges and after deducting there from an goviding there outgag applicable if want-but Load and adding thereto any redemption charges in the form of Back-end Load, shall constitute part of the Fund Property and includes the investment and all income, profit and other benefits arising there from and all cash, bank balances and other assets and property of every description for the time being held or deemed to be held upon trust by the Trustee for the benefit of the Unit Holder(s) pursuant to this Deed.
- 14.2 The Fund Property shall initially be constituted out of the proceeds of the Units issued to the Core Investors and other Units issued during the Initial Period after deducting any applicable Duties and Charges there from or any Front-end Load as provided in the Offering Document.
- 14.3 The Trustee shall take the Fund Property into its custody or under its control either directly or through the Custodian and hold it in trust for the benefit of the Holders ranking party passor inter se, according to the number of Units held by each Holder(s) in accordance with the provisions of the Regulations and this Deed. The Fund Property shall always be kept as a separate property and shall not be applied to any purpose unconnected with the Scheme such as to make a loan or advance. All registerable investment shall be registered in the name of the Trustee and shall remain so registered until disposed off or transferred to new trustee pursuant to the provisions of this Deed. All expenses incurred by Trustee in effecting such registration shall be payable out of the Fund Property.
- 14.4 Save, as herein expressly provided, the Fund Property shall always be kept as separate property free from any mortgages, charges, liens or any other encumbrances whatsoever and the Trustee or the Custodian shall not except as allowed under the Regulations create apply, mortgages, charges, liens or any other encumbrances whatsoever to secure any loan, coalingtee, or any other obligation actual or consingent incurred, assumed or undertaken by the Totale, the Custodian or any other person except for securing finances obtained from Balks of institutions upon the direction of the Management Company for redemption of I, Units, epit subject to the limitations contained in the Regulations.
- 14.9 The Letter shall have the sole responsibility for the safe-keeping of the Fund Property in its own paths for the benefit of the Trust. Subject to the provisions of Clause 11.3, in the event of any loss due to negligence or willful act and/or omission on part of the Trustee, the Trustee the lost Investment forthwith with similar investment of the same class and issue together with all rights and privileges pertaining thereto or compensate the Trust to the extent of any such loss. ### 15 INVESTMENT OF THE FUND PROPERTY

- 15.1 During and prior to the commencement of the initial Period the Trustee as advised by the Management Company shall hold the Fund Property in a separate account with Scheduled Commercial Bank(s) having at least AA rating as per the orderia laid down by a credit rating agency approved by the SECP, and selected by the Management Company Any income from such investments shall accrue to the Fund. After the Initial Period all cash, except in so far as such cash as may in the opinion of the Management Company be required for transfer to the Distribution Account, shall be invested by the Trustee from time to time in such Authorized investments as may (subject always to the Regulations, provisions of this Deed and Offering Döcument) be directed by the Management Company in terms of the Investment Strategy of the Fund.
- 15.2 Any Investment may at any time be realized at the discretion of the Management Company either in order to invest the proceeds in other Authorized investments or to proceed cash required for the purpose of any provision of this Deed or in order to retain the proceeds of sale in cash or on deposit as aforesaid or partly one and partly another. Any investment which ceases to be an Authorized investment shall be realized and the net proceeds of realization shall be applied in accordance with this Clause.
- 15.3 The purchase or sale of any Investment in listed securities for the account of the Trust shall be made on the Stock Exchange through a broker who must be a member of the Stock Exchange, unless the Management Company is satisfied that it is possible to make such purchase or sale more advantageously in some other manner. The broker shall be appointed, from time to time, by the Management Company under intimation to the Trustels. The Management Company shall specify criteria for providing a diverse panel of Broker's table the time of the offering of the Scheme and avoid undue concentration with a single freely following the limitations specified in the Regulations, Save as allowed under the Regulations, the Management Company shall not enter into transactions with any broker, which exceed thirty percent of the commission charged to Fund in any one Accounting enter.
- 15.4 The Fund Property shall be subject to such exposure limits as are provided in the Regulations / Circulars: provided that the Management Company shall have three months to comply with the exposure limits incase such limits are exceeded owing to appreciation or depreciation in value of any Investment, disposal of any investment or redemption of Units.
- 15.5 If and so long as the value of the holding in a particular company or sector shall exceed the limit imposed in a particular company and sector by the Regulations, the Trustee shall not settle any further investments made by the Management Company in such company or sector.
- 15.6 The Scheme shall not underwrite or subscribe to securities issued by group companies of the Management Company and shall not underwrite to issues underwritten, co-underwritten / sub-underwritten by such group companies.





### 16. PAYMENT OF UNITS IN FOREIGN CURRENCY

- 16.1 The Management Company shall appoint one or more scheduled -b@nk(e). Marxhbl Authorized Dealer(s), subject to SECP and SBP approvais, to manage Offer and Redemption of Units from outside Pakistan in foreign currency under the provisions of the Foreign Exchange Regulation.
- 16.2 Payments made in foreign currency to purchase units shall be converted into Pakistani Rupees through the Authorized Dealer using SBP's quoted rates (or NBP's in case SBP rates are not available) and any conversion cost, Duffes and Charges and Front-end Load, if any, shall be deducted from the payment before Units are issued. The Units issued will be denominated in Pakistani Rupees using the conversion rates quoted by the Authorized Dealer at the issue date of the Units (buying rate for the relevant currency).
- 16.3 Payments to be made in foreign currency on redemption of units shall be converted from Pakistani Rupees through the Authorized Dealer using his quoted rates (selling rate for the relevant currency) and any conversion cost, Duties and Charges, and Back-end Load shall be deducted from the payment to be made.

### 17. BASE CURRENCY

The currency of transaction of the Fund is the Pakistani Rupee and the Management Company, Trustee or any Distributor are not obliged to transact the issuance or redemption of the Units in any other currency and shall not be held liable.

### 18. VOTING RIGHTS ON FUND PROPERTY

- 18.1 All Crights of voting attached to any Fund Property shall be exercisable by the Management Company on behalf of the Trustee and the Management Company shall be entitled to exercise the said rights in what it may consider to be the best interest of the Holders and may refrain at its own discretion, in the interest of the Holders, from the placed only any voting rights and the Trustee or the Unit Holders shall not have any right to hoteled.
- 18.2 The Mustee shall upon written request by the Management Company and at their the professe, from time to time execute and deliver or cause to be executed or delivered to the Management Company or their nominoes powers of attorneys or proxies authorizing such attorneys and proxies to vote consent or otherwise act in respect of any investment in such form and in favor of such persons as the Management Company may require in writing.

The phrase "rights of voting" or the word "vote" used in this sub-clause shall be deemed to include not only a vote at a meeting but the right to elect or appoint directors, any consent to or approval of any arrangement scheme or resolution or any alteration in or abandonment of any rights attaching to any investment and the right to requisition or join in a requisition to convene any meeting or to give notice of any resolution or to circulate any statement as provided under the Ordinance. The Management Company shall keep a record stating the reasons for casting votes in favour of or against any resolutions.

18.3 The Trustee shall forward to the Management Company all notices of meetings and all reports and circulars received by the Trustee as the registered holder of any Investment.

### 19. BORROWING RESTRICTIONS

19.1 Subject to any statutory requirements for the time being in force and to the terms and deficients herein contained, the Management Company may arrange borrowing for account of the Scheme, by the Trustee, from Banks or financial institutions. The borrowing, however, shall not be resorted to, except for meeting the redemption requests and shall be repayable within a period of ninety days or such time as may be prescribed under the NBFC Regulations from time to time.

The charges payable to such Bank or institution should not be higher than the normal bank charges. Provided further that the maximum borrowing for the account of the Trust shall not exceed the limit provided in the Regulations but if subsequent to such borrowing, the Net Assets have reduced as a result of depreciation in the market value of the Fund Property or redemption of Units, the Management Company shall not be under any obligation to reduce such borrowing.

- 19.2 For the purpose of securing any such borrowing the Trustee may on the written instruction of the Management Company mortgage, create charge or piedge in any manner all or any part of the Fund Property provided that the aggregate amount to be secured by such mortgage, charge or piedge shall not exceed the limit provided in the Regulations.
- 19.3 Neither the Trustee nor the Management Company shall be required to issue any guarantees or provide security over their own assets for securing such borrowings from banks and Financial Institutions: The Trustee or the Management Company shall not in any manner be liable in their personal capacities for repayment of such loans or advances.
- The Trustee or the Management Company shall not incur any liability by reason of any loss that a Unit Holder may suffer by reason of any depletion in the Net Selet Value that may result from any borrowing arrangement made hereunder in good faith.

### VALUATION OF PROPERTY

The method of determining the value of the assets and liabilities of the Trust Property and the Net Assets shall be in compliance with the NBFC Regulations and is stated herein below:



stamp duty or taxation whether national, flumicipal or otherwise leviable in that country in respect of such payment or redemption. It is clarified that the offer and redemption price will be in rupee terms and the Scheme will not carry any exchange risk. The investor will invest at the exchange rate prevailing at that time and payments will made in rupees and investor will be responsible for converting it into relevant foreign currency.

23.3 The Management Company shall arrange the remittance and / or fuffil any foreign exchange formalities at State Bank of Pakistan (SBP) through Trustee (if required) at its own expense. Furthermore, in case of any remittance is delayed or cannot be made due to in-availability of foreign currency from the State Bank of Pakistan and / or delay due to approval process at SBP, both management company and Trustee will not be responsible for the same.

## 24. DETERMINATION OF OFFER PRICE

- 24.1 During the Initial Offer Period, the units will be offered at the Par Value. After the Initial Period the Offer Price shall be determined from time to time pursuant to Clause 24.2 hereafter and the Regulations, calculated and announced by the Management Company on each Business Day.
- 24.2 The Offer Price shall be equal to the sum of:

In the event that the amount paid as provision for payment of Duties and Charges pursuant to Sub-clause 24.2(c) is insufficient to pay in full such Duties and Charges, the Management Company shall be liable for the payment in full of the amount of such Duties and Charges in excess of such provisions (except where such excess arises from any Duties and Charges levied with retrospective effect after the date of payment in which case such excess shall be recovered from the Fund Property.

- 24.4 In the event the amount paid as provision for payment of Duties and Charges pursuant to Clause 24.2(c) exceeds the relevant amounts of Duties and Charges, the Management Company shall instruct the Transfer Agent to issue additional Units or fractions thereof to the Unit Holder based on the price applicable to the Units issued against the relevant application, or refund such excess amount to the relevant Holders immediately.
- 24.5 The Offer Price determined by the Management Company shall be announced and made available to the public at its website by 6.30 p.m. or such other time as may be allowed by SECP, the office and branches of the Distribution Company(s) on all Subscription Days and at the discretion of the Management Company may also be published in at least two daily

#### 25 ALLOCATION OF FRONT-END LOAD

- 25.1 The Trustee shall pay to the Management Company's order such sums out of the sale proceeds of Units as are representative of Front-end Load specified in the Offering Document or Supplemental Offering Document, if any, as being payable out of the Offer Price.
- 25.2 The remuneration of Distribution Companies shall be paid exclusively from any Front end Load received by the Trustee and no charges shall be made against the Fund Property or the Distribution Account in this respect. The remainder of any Front-end Load, after such disbursement, shall be paid by the Trustee to the Management Company.
- 25.3 Such payments, on the instructions of the Management Company shall be made to the Distribution Company(s) or the Management Company to the Trustee for onward payments to them on account of the Management Company on a monthly basis in arrears within thirty days of the end of the calendar month.
- 25.4 A Distributor located outside Pakistan may, if so authorized by the Trustee and the Management Company, retain such portion of the Front-end Load as is authorized by the Management Company and transfer the net amount to the Trustee, subject to the law for the time being in force.

#### 26. REDEMPTION OF UNITS

- In the event of redemption of certain class of Units, a Back-end Load, as per the Offering Document, shall beycharged to the Unit Holders while determining the Redemption Price.

- 26.5 The amount payable on redemption shall be paid to the Holder or first named joint Holder or any other joint Holder specified in the application for redemption of Units by dispatching a cheque / bank draft / pay order for the amount to the registered address of the Holder or other means, within six Business Days from the date of presentation of the duty completed redemption application at the Authorized Branch or office of the Distribution

Company. The Management Company may make arrangements for making transferring the redemption proceeds to the Holder's designated bank his account.

- 26.6 The receipt of the Holder for any moneys payable in respect of the Units shall be a good discharge to the Trustee and if several persons are registered as joint Holders any one of them may give effectual receipt for any such money.
- 26.7 Application for redemption of Units shall be received at the authorized offices or branches of the Distribution Company or Transfer Agent on all Business Days.
- 26.8 The Distribution Company or Transfer Agent shall verify the particulars given in the application for redemption of Units. #### SUSPENSION OF ISSUE OR REDEMPTION OF UNITS

The Management Company may, suspend the issue or redemption of Units at any time for an indefinite period, during:

(a) any period when the Stock Exchange on which any of the Investment for the time being is listed or dealt in is closed or when dealings in such Investment are restricted or suspended;

the existence of any state of affairs or Force Majeure which in the opinion of the Management Company constitute an emergency as a result of which disposal of any of the Investment would not be reasonably practicable or might seriously prejudice the interest of the Trust or the Unit Holdens:

- (d) any period when remittance of money which shall or may be involved in the realization of such investment or in the payment for such investment cannot in the opinion of the Management Company be carried out in reasonable time;
- if the Management Company is of the view that it would be detrimental to the remaining Unit Holders to redeem or continue to redeem Units at a price ascertained on the basis of the Net Asset Value;

(g) For the suspension of redemption of Units, prior approval of board of directors of the Management Company is required.

In case of suspension of redemption of the units of the Scheme, the Management prompany shall also suspend issuance of fresh units of the Scheme until and unless Owdemption of units is resumed.

#### QUEUE SYSTEM AND WINDING UP

Quigué System — In the event redemption requests for Units on any day exceed ten pleash (10%) of the Units in issue, the Management Company may invoke a queue system whereby requests for redemption shall be processed on a first come first served basis for up to ten percent (10%) of the Units in issue. proceeds may be made if the Management Company finds it feasible.



- 30.1 The Register shall be maintained by the Management Company or if appointed, by the Transfer Agent at such a place as is agreed by the Management Company. The Management Company shall ensure that the Transfer Agent shall comply with all relevant provisions of this Deed and the Regulations.
- 30.2 The Management Company shall ensure that the Transfer Agent shall at all reasonable times during business hours give the Trustee and its representatives access to the Register and to all subsidiary documents and records or certified copies thereof and to inspect the same with or without notice and without charge but neither the Trustee nor its representatives shall be entitled to remove the Register for to make any entries therein or alterations thereto and except when the Register is closed in accordance with the provisions of this Deed, the Register shall during business hours (subject to such réstrictions as may be mentioned in the Offering Document and for a period of at least two hours in each Business Day) be open in legible form to the inspection of any Unit Holder of his record without charge.

In case any Certificate shall be lost, stolen, mutilated, defaced or destroyed, the Transfer Agent with the approval of the Management Company may issue to the person entitled new Certificate in lieu thereof. No such new Certificate shall be issued unless the applicant shall previously have:

- returned the mutilated or defaced Certificate or furnished the Distribution Company / Transfer Agent evidence satisfactory to the Management Company of the loss, theft or destruction of the original Certificate:

34.7 The Distribution Company / Transfer Agent with the prior approval of the Management Company and the Trustee shall be entitled to destroy all instruments of transfer or the copies thereof as the case may be which have been registered at any time after the expiration of ten years. The Trustee or the Management Company or the Distribution Company / Transfer Agent shall be under no liability whatscover in consequence thereof and it shall conclusively be presumed in favor of the Trustee or the Management Company or the Distribution Company / Transfer Agent that every instrument of transfer so destroyed was a valid and effective instrument duly and property registered by the Trustee or the Management Company or the Distribution Company / Transfer Agent and that every Certificate so destroyed was a valid certificate duly and property canceller.

The Transfer Agent shall take a note of the pledge / lien charge in his record, whether the Certificate has been issued or not, provided sufficient 6 violence of pledge to the satisfaction of, the Management Company, Trustee and the Transfer Agent along with a joint request from the Unit Holder and the pledgee is submitted physically or electronically on the standard application form, as given in the Offering Document. None of these parties, the Trustee, the Management Company, or the Transfer Agent, shall be liable for ensuring the validity of any such pledge / fien / charge / lien. The discursement of any loan against the constitution of such pledge / fien / charge shall be at the entire discretion of the lender and registers of the property of the lender and registers and the smaller.

Salve any legal bar or court order requiring otherwise, any dividends that are declared on the pledged Units shall be made to the order of the Holder. However, any additional Bonus Units: That the pledged Units are entitled to automatically be marked under the lien of the Holder and in the event the pledged Units are redeemed for any reason whatsoever, the proceeds shall be paid to the order of the Holder.

The lien once registered shall be removed by the authority of the party in whose favor the lien has been registered or through an order of a competent court. Neither the trustee, nor the Management Company, nor the Transfer Agent, shall be liable for ensuring the validity of any such pledge/charge/lien.

#### 36 FEES AND CHARGES

#### 36.1 Remuneration of Management Company

The Management Company shall be entitled to an accrued remuneration equal to an amount not exceeding three percent of the average annual net assets of the Collective Investment Scheme that has been verified by the Trustee and is paid in arrears on monthly basis during the first five years of existence of the Scheme and thereafter of an amount equal to two per cent of such assets or such other amount as may be specified by the Commission.
- b. The remuneration shall begin to accrue from next day of closing of initial Period. In respect of any period other than a full Accounting Period such remuneration shall be prorated on the basis of the actual number of days for which such remuneration has

accrued. The remuneration due to the Management Company shall be paid in arrears within 15 (fifteen) Business Days after the close of each calendar month and after the receipt of instruction by the Trustee

- c. In consideration of the foregoing and save as aforeseld the Management Company shall be responsible for the payment of all expenses incurred by the Management Company of the Trust. The Management Company with its responsibilities as Management Company of the Trust. The Management Company shall not make any charge against the Unit Holders or against the Fund Property or against the Distribution Account for its services or for its expenses, except as are expressly authorized under the provisions of the Regulations and this Deed to be payable out of the Fund Property.
- d. The Management Company shall bear all expenditures in respect of its secretarial and office space and professional management, provided in accordance with the provisions of this Deed.

#### 36.2 Remuneration of Trustee

a. The Trustee shall be entitled to a monthly remuneration out of the Fund Property to an annual tanff of charges annexed hereto (Annexure C), which shall be applied to the average daily Net Assets during such calendar month. The remuneration shall begin to accrue from the next day of close of Initial Period. - d. The Trustee shall bear all expenditures in respect of its secretarial and office space and professional management, in accordance with the provisions of this Deed.
- Any increase in the remuneration of the Trustee agreed to by the Management Company shall require the approval of the Commission.
- f. The Trustee shall however not make any further charge against the Unit Holder(s) nor against the Trust Property nor against the Distribution Account for its services nor for expenses, except such expenses or fees as are expressly authorized under the provisions of the Regulations and the Trust Deed to be payable out of Trust Property.

#### 36.3 Formation Cost

All expenses incurred in connection with the establishment and registration of the Scheme including, but not limited to, execution and registration of the Constitutive Document (s), issue, legal costs, printing, circulation and publication of the Constitutive Document (s) and Offering Document (s), and all other expenses incurred during the Initial Offering Period, shall be borne by the Management Company and shall be reimbursable by the Fund, subject to the audit of expenses. The formation cost shall be amortized over a period of five years or any other time period as specified by the Commission.

  - (k) hedging costs including forward cover, forward purchase or option purchase costs;
    - (i) prioring costs and related expenses for issuing the quarterly, half-yearly and annual reports, of the Fund;
    - (m) taxels, fees, duties and other charges applicable to the Fund on its income or its properties, including taxes, fees, duties and other charges levied by a foreign jurisdiction on #19/81/ments made overseas.
    - (n) arily other expense or charge as may be allowed by the Commission.

6.5 Any cost associated with sales, marketing and advertisement of the Scheme shall not RACOS charged to the Scheme.

## 7 TRANSACTIONS WITH CONNECTED PERSON

37.1 The Management Company on behalf of the Collective Investment Scheme shall not without the prior approval of its Board of Directors in writing and with consent of trustee, purchase from, or sell any securities to any connected person or employee of the Asset Management Company;

This clause shall not apply to the issue, sale or redemption of units issued by the Collective Investment Scheme.

37.2 The Fund Property shall not be invested in any security of a company if any director or officer of the Management Company individually owns more than five per cent (5%) of the total amount of securities issued, or, the directors and officers of the Management Company own more than ten per cent (10%) of those securities collectively.

- 37.3 Where cash forming part of assets of Collective investment Scheme is deposited with the trustee or the Custodian that is a banking company or an NBFC, a return on the deposit shall be paid by such Trustee or Custodian at a rate that is not lower than the rate offered by the said banking company or NBFC to its other depositors on deposits of similar amount and maturity.
- 37.4 All transactions with connected persons carried out by an Asset Management Company on behalf of the Collective Investment Scheme shall be in accordance with the provisions of the Constitutive Documents and shall be disclosed in the annual report of the Collective Investment Scheme.

#### 38 Distribution Policy and Date

- 38.1 At least 90% of the income, [excluding unrealized capital gains], received by the Fund reduced by such expenses as are chargeable to the Fund under the Regulations shall be distributed annually. The Management Company shall decide as soon as possible but not later than forty-five days after the Accounting Date whether to distribute among Unit Holders, profits, if any, available for the distribution at the end of the Accounting Period to comply with the requirement of the Regulations, the tax laws and other regulations in force relating to income distribution and shall advise the Trustee of the rate of such distribution per Unit.
- 38.2 The amount available for distribution in respect of any Accounting Period shall be determined by the Management Company after consulting the Auditor and shall be the sum total of:
  - (a) the total income earned on the Fund Property during such Accounting Period including all amounts received in respect of dividend, mark-up, profit, and fee;

whole or part of the net realized appreciation, at the option of the Management Company;

from which shall be deducted expenses as set out in Clause 38.4, adjustment as set out in Clause 38.5 and such other adjustment as the Management Company may determine in consultation with the Auditor. The sums may be different depending on different types of units with the explicit permission of SECP.

The amount so determined may be distributed among the Unit Holders within one month of announcement of such distribution.

- 38.3 The proceeds of sales of rights and all other receipts deemed by the Management Company after consulting the Auditor to be in the nature of capital accruing from Investments shall not be regarded as available for distribution but shall be retained as part of the Fund Property , provided that such amounts out of the sale proceeds of the Investments and out of the sale proceeds of the rights, bonus shares and all other receipts as deemed by the Management Company after consulting the Auditor to be in the nature of the net gain may be distributable to the Idolders by the Trustee and shall thereafter cease to form part of the Deposited Property once transferred to the Distribution Account.
- 38.4 The income qualifying for distribution in respect of the relevant Accounting Period shall be ascertained by deducting:

#### 39 DISTRIBUTION OF INCOME

39.1 The Management Company may decide to distribute, wholly or in part, the distributable income in the form of Bonus Units or cash dividends. After fixing of the rate of bonus distribution per Unit, in case of distribution in the form of Bonus Units the Management Company will inform the Trustee who shall cause to have additional Units issued in the name of the Unit Holders as per the bonus ratio.

To case of cash dividends, the Management Company shall instruct the Trustee to transfer such abount of cash as required to effect such distribution to the Distribution Account. "péfore making any payment in respect of a Unit, the Trustee or the Management Company may make such deductions as may be required by law in respect of any Zakat, income or other taxes, charges or assessments whatsoever and issue to the Unit Holder the certificate in respect of such deductions in the prescribed form or in a form approved or required by the concerned authorities.

In case of cash dividends, distribution payments shall be made by warrant? cheque / pay order or by way of transfer of amount to the Unit Holder's designated bank account by the Trustee or sent through the registered post to the registered address of the Joint Holder, first named on the Register. Every such warrant shall be made payable to the order of the unit holder and payment of the warrant (if purporting to be duly endorsed or subscribed) shall be in satisfaction of the money payable. - 40.1 The Annual Accounting Period shall commence on 1<sup>st</sup> July and shall end on 30<sup>th</sup> June of the ensuing calendar year.
- 40.2 Accounting Date shalfbe the 30<sup>th</sup> day of June in each year and any interim dates at which the provided to the Fund are drawn up. Provided, however, that the Management Sompany may, with the consent of the Trustee and after obtaining approval of the Commission and the Commission of Income Tax, change such date to any other date.
  - Accounting Period shall be the period ending on and including an Accounting Date and patientening (in case of the first such period) on the date on which the Trust Property is first pad or transferred to the Trustee and (in any other case) from the end of the preceding Accounting Period.

#### AUDIT

- 41.1 The Management Company shall appoint, as per provisions of the Rules and Regulations, an Auditor, with the consent of the Trustee, who shall not be the Auditor of the Management-Company and the Trustee. The Management Company may at any time remove the Auditor and appoint another Auditor in its place. The same firm of chartered accountants cannot be appointed Auditor for more than five consecutive years.
- 41.2 The Auditor shall hold office until transmission of the annual report and accounts but may be re-appointed as per the Rules and the Regulations.
- 41.3 The persons not qualified to be the Auditor of a public company under the Companies Ordinance shall not be qualified to be the Auditor.
- 41.4 Appointment of a partnership firm to be the Auditor shall be deemed to be the appointment of all persons who are partners in the firm for the time being.
- 41.5 The Auditor shall have access to the books, papers, accounts and vouchers of the Trust,





whether kept at the office of the Management Company, Trustee, Custodian, Transfer Agent or elsewhere and shall be entitled to require from the Management Company, Trustee; Custodian, Transfer Agent and their officers and agents such information and explanations as considered necessary for the performance of audit.

- 41.6 The Auditor shall prepare a written report to the Unit Holders on the account and books of accounts of the Trust and the balance sheet and income statement and on every other document forming part of the balance sheet and income statement, including notes, statements or schedules appended hereto.
- 41.7 The contents of the Auditors report shall be as required in the Regulations.
- 41.8 The Trustee shall be entitled to require the Auditors to provide such further reports as may be agreed between the Trustee and the Management Company to facilitate the Trustee in issuing the certification required under Regulations.

#### MODIFICATION OF THE TRUST DEED

42.1 The Trustee and the Management Company acting together shall be entitled to modify, after or add to the provisions of this Deed in such manner and to such extent as they may consider expedient for any purpose, subject only to the approval of SECP, if so required. Provided that, the Trustee and the Management Company shall certify in writing that, in their opinion such modification, alteration or addition is required pursuant to any amendment in the Regulations or to ensure compliance with any fiscal or statutory praurement or to enable the bristones of this Deed to be more conveniently or economically managed or to enable the Units to be dealt in or quoted on the Stock Exchange or gifter wise for the benefit of size Holders and that it does not prejudice the interests of the Unit. Holders or any of them or operate to release the Trustee or the Management Company from any responsibility to the Holders.


Where this Deed has been altered or supplemented the Management Company shall notify the Unit Holders immediately by publication in a widely circulated newspaper in Pakistan.

42.4 If at any time, any Clause of this Deed is and/ or becomes in whole or in part, illegal, invalid or unenforceable under the laws of any applicable jurisdiction, neither the legality, validity and enforceability of the remaining Clauses of this Deed hereof, nor the legality, validity or enforceability of such Clause under the law of any other jurisdiction shall in any way be affected or impaired thereby.

#### 43. REVOCATION AND LIQUIDATION OF TRUST

- 43.1 The Trust may be terminated by the Commission on the grounds given in the Rules and/or the Regulations.
- 43.2 The Management Company, after the prior written approval of the Commission, shall give at least three months notice to Unit holders and trustee if it intends to have the registration of the Fund cancelled.

43.3 At the end of the notice period given under 42.2 above, the Commission will stiple of the in writing cancel the registration of the Fund.

43.4 Upon representation to the Commission, by three fourth in value of the total unit holders of the Fund, or if in the opinion of the Commission further continuation of the registration of the Scheme will be detrimental to the interest of the unit holders or the market generally, the Commission may cancel the registration of the Scheme;

Provided that the registration of the Scheme shall not be cancelled without providing an opportunity of being heard to the Management Company and the trustee.

- 43.5 In case of cancellation of registration, the Management Company shall revoke the Scheme and refund the proceeds to the unit holders in such manner and within such time as may be specified by the Commission.
- 43.6 Notwithstanding anything contained in any other provision, where in the opinion of the Commission or the Management Company any delay in the revocation of a Scheme is detrimental to the interest of the unit holders, the Commission may direct the immediate revocation of the Scheme without first canceling the registration or providing an opportunity of being heard to the Management Company in such manner and within such time as may be specified by the Commission.
- Where the Commission grants approval under the Regulations or cancels the registration of Physicheme or orders the revocation of the Scheme, all issuance and redemption of units of the Scheme shall stand suspended immediately.
